### YOUTH BOARD MEMBER APPLICATION

The National Indian Child Welfare Association (NICWA) Board of Directors is a working board that is responsible for policy-making and fiscal oversight of the organization. Youth board members are full voting members of the NICWA board; they have the same duties and responsibilities as all board members, with the exception of an exemption from the individual fundraising requirement.

Youth board members are expected to support the goals and purposes of NICWA, as set forth in the bylaws, through their membership and actions. Youth board members must maintain current NICWA membership. Youth board members may pay the student rate for NICWA membership, and if this poses a financial hardship, should notify the executive director, who will provide a membership to them free of charge. The board typically meets at least four times per year, and all board members are encouraged to support their own travel costs if possible (for example, with support from their tribe). Funding is available to support travel to any in-person meetings for board members who are unable to cover the cost themselves.

All board members are required to attend meetings regularly. Youth board members are encouraged to serve on all board committees, with the exception of the Executive Committee, in order to gain experience with the varied subject matter and areas of responsibility. Youth board member benefits include opportunities to learn, network, shape policy, and bring new resources to Indian child welfare. Please consider what you can contribute and what experience, knowledge, and relationships you hope to gain. A youth board member job description and committee descriptions are attached for your information.

Youth board members will be selected to join the slate of nominees to the NICWA board based on a combination of the following factors:

- Interest in a career in Indian child welfare, social work, psychology, or other related fields;
- Lived experience in tribal or state foster care, or experience interacting with other “helping systems” like children’s mental health or family support (preferred but not required); and
- Cultural engagement, values, skills, and interests.
